Everyone tries, where and whenever possible, to unburden the customer. By daily anticipating and tapping new channels means for Hazet continuity. It is a daily challenge to get things done. What do we get a lot done, together!

We act in accordance with the laws and regulations applied. To meet our aforementioned social responsibility (Corporate Social Responsibility, CSR) we work according to internationally accepted standards, including the ILO and UN Global Compact, and basically according to the precautionary principle.

We are committed to reducing the damage to the environment and to improve our energy performances in business processes by means of promoting and purchasing energy-efficient products, services and processes. We separate paper, clothing, plastic, toners and batteries, allow old machines to be taken up and dispose it in a responsible way. In recent years Hazet has invested in new trucks with engines which are equipped with a Euro 6 standard. All our trucks and vans are also equipped with a state-of-the-art navigation system and have track-and-trace.

Our rides are automatically scheduled by using a ride planning system. The constant drive for improvement should achieve and maintain the desired situation. In addition, in the policy statement, we guarantee fair and secure conditions of employment, the safety of workers and those of third parties, the promoting of well-being and by that reducing absenteeism, preventing human suffering from accidents, injuries and illness, we fight for the protection of international human rights and we are committed to fight corruption. Safety priorities are set in the business data from accident and incident reports, risk assessments and other safety data. These goals apply to our joint production chain: from producer to end user.





As far as suppliers and service providers are concerned, we maintain a careful selection of their environmental performance, prevailing working conditions, business rules and strategic design carried out by regular checks in the form of a supplier audit. In this way, we also secure our high quality internally through organizational guidelines and technical measures, as well as the necessary training. By the Internal complaint department as well as regular internal and external checks allow us continuous development.

- Creating an open communication culture;
- Creating and stimulating (safety) awareness;
- Maintain a good relationship with our stakeholders;
- Preventing and reducing industrial accidents and/or (environmental) damage.

We continuously keep ourselves informed of (technical) developments and the latest state of legislation and regulations in order to permanently guarantee the suitability, adequacy and effectiveness.

Continuously improving our system is integrated in our daily activities. Quality, occupational health and safety, the environment and food safety play a central role in this. We work on effi cient and fl exible processes and continuous improvement.
